MINUTES / NOTES

Meeting called to order at 19:33 by Commissioner Duffy.

Pledge of Allegiance was recited by all.

Commissioner Duffy read the Open Public Meeting Act as follows:

THIS MEETING IS BEING HELD IN ACCORDANCE WITH THE REQUIREMENTS OF THE OPEN PUBLIC MEETING ACT (L.1975, C.231) AND PURSUANT THERETO, A SCHEDULE OF REGULAR MEETINGS WAS ADOPTED AT THE MEETING OF MARCH 8, 2016, WHICH SCHEDULE WAS FILED WITH THE MUNICIPAL CLERK, PROVIDED TO THE HOME NEWS TRIBUNE AND THE SENTINEL, AS WELL AS POSTED IN THE MUNICIPAL BUILDING.

Commissioner Duffy indicated where the emergency exits are located.

Roll call was taken.

REORGANIZATION (read by Commissioner Miller)

The Fire Commissioners nominated who would perform in what positions on the board for the year.

Commissioner Miller read the following:

- Secretary – Commissioner Scott Miller was nominated by Commissioner Duffy; it was seconded by Commissioner Wood
- Clerk – Commissioner Thomas Duffy was nominated by Commissioner Miller; it was seconded by Commissioner Wood

- Treasurer – Commissioner Dave Wood was nominated by Commissioner Miller; it was seconded by Commissioner Duffy

All were in favor of the nominations; they were so elected.

Commissioner Bowne was absent and will read aloud the Oath of Allegiance at the next meeting he is in attendance for. He was voted in to another term of being a Commissioner for Fire District #3.

Commissioner Miller read allowed eight (8) resolutions to which the board of Commissioners took a roll call vote for each of them. All were passed by the Commissioners. Commissioner Scott Miller certified each of the roll call votes. Resolutions and roll call votes are attached at the end of these minutes. The meeting continued with the standard monthly agenda.

CORRESPONDENCE (reported by Commissioner Miller)

- Received letter from Mall Chevrolet about the Tahoe. It had a recall and has to be served to fix the front air bags and the way they deploy. The letter was given to the engineer who in turn reviewed his files. He confirmed that this recall has already been repaired. It was done somewhere other than Mall Chevrolet where the truck was purchased.
- Received the new registration for the boat trailer – this was given to the engineer as well.
- Received a second notice for an annual local government survey – Commissioner Miller stated he will take care of this request after the meeting.

INSURANCE (reported by Commissioner Duffy)

- All insurance matters are up to date.
- Commissioner Duffy reminded those in attendance that if anyone gets hurt to contact him so he can receive a claim number from the insurance company so they can take care of matters.

LOSAP (reported by Commissioner Miller)

- New documentation regarding the firefighters was presented to the Commissioner from the Assistant Chiefs. Commissioner Miller will pass it along to Commissioner Fenstermaker who handles all matters related to LOSAP and report back at the next meeting.

PUBLIC PORTION

Chiefs Report and other items – reported by Asst Chiefs Kevin Umbach & Mike Heilbronn

- There were 12 calls for the month of February bringing the total to date up to 28 alarms.
- Umbach also reported that there were already 15 alarms in March.
- Lieutenant Van Aulen is working on the OSHA injury report that was requested.
- Riva Ave & Church Lane will be closed completely next week for a period of a week for contractors to work on the road. The roads will be completely unavailable to residents and fire trucks. New routes for the neighboring roads have been mapped out in case the firefighters need to attend to an alarm in those areas. There is some concern about accessing Darby Road as this road because it would need to be accessed through the next town over. Asst Chief Umbach will let that district know of this possibility.
- The new camera was ordered for #903 and will be installed within the next few weeks by Bullard. The camera was actually more expensive than was originally expected.

- Heilbronn inquired about what was left on the new truck budget. Commission Wood stated that the Township overpaid us and we have to return money back to them. Will be discussed during Treasury Report section.
- Heilbronn requested to purchase a few more pieces of equipment for the engines. They are 2 6-foot hooks, 1 6-foot pile pole, 1 drywall hook. He has requested this come out of the hand tool budget for this year. Requested approval to spend up to \$500.00.
- Heilbronn also requested to purchase a new multi gas meter with the necessary hardware from Draeger for the new rescue truck. He has requested this to come out of the fire hose budget. Approval requested to spend up to \$1,000.00 on this.
- Heilbronn also noted that they underspend when purchasing the Ice Rescue equipment. There is a net of about \$1,566.00 remaining. He was hoping this surplus could cover the overage spent on the camera and flow coats. Commissioner Miller was concerned about requesting funds to purchase one thing and then changing that original request and use it to pay for another. Commissioner Wood confirmed that this can be done as long as the explanation of why the change and how it was moving was presented on the floor during these meetings.

Commissioner Miller made a motion to purchase the hand tools listed above not to exceed \$500.00. Commissioner Wood seconded that motion. All were in favor; it was so moved.

Commissioner Miller also made a motion to purchase the gas meter not to exceed \$1,000.00. Commissioner Wood seconded that motion. All were in favor; it was so moved.

Engineers Report - reported by Ken Skalla

- SCBA batteries were changed out
- #902 getting compartments reconfigured – should be done soon
- #904 has a Ritt pack leak. Vendor is going to pick it up to look at it.
- Would like to take the siren out of the Crown Victoria and put it into Bronco since the siren is shot. Commissioner Wood agreed to this. Jolly to strip Crown Vic before sale and then mount siren onto Bronco. An estimate is requested to be obtained for this to be done.

Firefighter Training

Captain Phil Foglia who is also the Training officer reported that the live burn training that was supposed to happen on March 11th has to be rescheduled.

COMMITTEES

RIVA Ave Project (reported by Commissioner Duffy)

- The bathrooms have been ripped out of Riva Ave and there was a need to rent a Port-a-John for the next 6 months while the building is being renovated. The fire house asked if the Commissioners would pay for this. They stated yes, and that it would come out of the building funds. A reimbursement request was submitted by the fire company for the month they paid. Commissioners asked that someone from the fire house contact the Port-a-John facility to see if they could send the invoice directly to them so they can pay it in the future. This will be paid through the building funds budget.
- Additional paperwork was requested from the township about the building for the Engineering department.
- Contractor, Architect and Commissioner Duffy have reviewed things.
- Architect completely understands what the fire company's needs are in the building.

- Builder reported that he was not happy with the mark out of the project. He is worried about other things not being identified. The gas line was not marked from the back building. A price of \$5,036.32 was quoted to move line from back building. However there may be a generated placed in this building. The builder had a radon check done which cost about \$7,300.00 to complete. Commissioner Duffy doesn't think they need the property to be redone.
- The builder found a void in the buildings foundation which contained a bunch of water. He also discovered windows in walls that had been covered up in the walls. Commissioner Duffy will be getting together with the building committee to discuss these findings.
- Builders are also asking about drawings on how to support walls when redoing them. Our Attorney, Architect and Commissioner Duffy all agree that it's the builders' responsibility to figure that out.

Commissioner Duffy made a motion to reimburse the fire company for the port-a-john. Commissioner Miller seconded that motion. All were in favor; it was so moved.

TREASURY REPORT (reported by Commissioner Wood)

Commissioner Wood reported that we are in the middle of an audit. There was a list of things found by the auditor that Commissioner Wood and Christine Gerbereux have to address right away. There were some questions regarding the cost of Hearst equipment that was asked of the Chiefs in attendance. One of the biggest concerns was with the overpayment of truck funds from the township. They paid out \$640K and the voters only approved \$625K. The total owed to the township is \$19,137.00

Also at the last meeting, a wrong quote for the scot packs were given. Asst Chief Umbach stated the new official quote is \$23,666.80.

Lastly, Commissioner Wood received a letter from Lou Neely regarding a missed payment on the building. We defaulted on the March 1st payment. We will be paying it tonight. In the future, we don't need to wait until a meeting to process a check for this payment since it was already approved by the voters. Lou Neely requested a policy be put in place so this doesn't happen again. The Commissioners decided the policy would be that they would pay things a month in advance of when it is due so this doesn't happen again. Commissioner Wood will let Lou Neely know of their policy. Commissioners Miller and Duffy agreed to this arrangement. Commissioner Duffy to drop off late payment to Neely tomorrow after check is signed tonight.

Beginning balance in account as of 2/14/17 was \$1,053,003.72. After disbursements tonight and deposits balance is \$830,004.88.

Commissioner Miller made a motion to pay the bills. Commissioner Wood seconded the motion. All were in favor; it was so moved.

OLD BUSINESS:

- Received a letter from District #1 regard the Crown Victoria. They do not want it back and are OK with the sale of it on GovDeals.com. There are a few things that will come off of this vehicle that are new before it is posted. Commissioner Fenstermaker will handle the sale of this vehicle on GovDeals.com

NEW BUSINESS

- Engineer Ken Skalla and Captain Phil Foglia saw Rick Toomey working on the Crown Victoria last week. Tonight when Commissioner Duffy arrived at the firehouse for the meeting he looked into the Crown Victoria and saw the whole center console and radios were missing. The other Commissioners were wondering how he might have gained access to the car and Assistant Chief Umbach questioned if

- Commissioner Miller stated that he will try to get in touch with Rich Toomey to see what he says about these accusations and the missing equipment and ask him to return all of it. If not he will report it to the police.







WHEREAS, Subchapter 4, Section 5:31-4.2 further provides that the Commissioners, at their reorganization meeting, designate, by resolution, the individuals whose signatures shall appear on checks drawn upon the treasury of the Commissioners; and

WHEREAS, Subchapter 4, Section 5:31-4.1(f) provides that the Commissioners shall, by resolution passed by not less than the majority of the full membership, further designate the manner in which the time in which salaries, wages or other compensation for services shall be paid.

NOW THEREFORE, be it RESOLVED by the Commissioners of Fire District No.3, in the Township of East Brunswick, County of Middlesex, as follows:

(1) The checks as issued by the Commissioners for payment of claims shall be signed by the President, Treasurer and countersigned by one other Commissioner in order that the Commissioners comply with the rules and regulations as promulgated by the Local Finance Board and as set forth herein.

(2) No more than one stamp facsimile shall be used on any particular check in place of a handwritten signature.

(3) The manner in which and the time in which compensation for services rendered by employees of the Commissioners shall be paid shall be in accordance with individual employment contracts. The Commissioners' salaries shall be paid as determined by the Commissioners.


