MINUTES / NOTES

Meeting called to order at 19:37 by Commissioner Bowne.

Pledge of Allegiance was recited.

Commissioner Bowne read the Open Public Meeting Act as follows:

THIS MEETING IS BEING HELD IN ACCORDANCE WITH THE REQUIREMENTS OF THE OPEN PUBLIC MEETING ACT (L.1975, C.231) AND PURSUANT THERETO, A SCHEDULE OF REGULAR MEETINGS WAS ADOPTED AT THE MEETING OF MARCH 10, 2015, WHICH SCHEDULE WAS FILED WITH THE MUNICIPAL CLERK, PROVIDED TO THE HOME NEWS AND THE SENTINEL, AS WELL AS POSTED IN THE MUNICIPAL BUILDING.

Commissioner Bowne indicated where the emergency exits are located.

Roll call was taken. Went right into the new truck purchase since the representative, John O'Keefe, was at the meeting.

NEW TRUCK PURCHASE (reported by Commissioner Miller)

On March 12, 2015 the firehouse received the price package from Pierce. The contract was reviewed by Richard Braslow, attorney and David Russell from the Fire and Safety. They resolved all concerns they had. Richard Braslow requested a statement to be added to the contract indicating that if the truck was not delivered by date purchased than we would charge back Fire and Safety \$100 per day for each day it was not delivered. The contract was signed this evening because Pierce has a price increase effective tomorrow. Our contract price was good until 11:59pm tonight. Commissioner Miller read the document regarding the purchase of the truck that was placed in the newspaper. This give the public a time to comment. Commissioner Bowne opened it up to the floor for public comments about this purchase. All accepted the order for One Pierce Arrow Fire Truck. The order form was signed by Commissioner Bowne. Commissioner Miller handed order to Pierce rep and shook his hand. The chassis was prepaid. IT will take approximately 18 months to build.

CORRESPONDENCE (reported by Commissioner Miller)

- They received the Lincoln Financial group Disclosure statement. It was given to Chris Gerbereux to file.
- Vehicle registration for the 1994 Wagon was received and given to Ken Skalla.
- Permits for the April Wedding event were received – Christine Gerbereux to forward onto District #1

LOSAP (reported by Commissioner Duffy)

- Signed by 2 commissioners. The check is written and ready to go

INSURANCE (reported by Commissioner Duffy)

- Workman's compensation is up for renewal. Commissioner Duffy got a quote where they can save up to 17% from one company. He will report on this next month.
- Insurance with Bollinger is also up for renewal. Trucks are fixed price. Commissioner Duffy is happy with them so we will most likely stay with them.
- Commissioner Miller asked when the new members are covered under regular insurance and it was reported that they are covered immediately.

RIVA AVENUE PROJECT (reported by Commissioner Duffy)

- They did not have to go for a sprinkler system but they went for it. It was recommended that it be put out for bid.

COMPUTERS (reported by Commissioner Wood)

- Had to put out \$400 to renew website where all District #3 posts meeting minutes and other items of interest. This renewal is good for 2 years.

PUBLIC PORTION

Chiefs Report – reported by Chief Michael Heilbronn

- See attached report regarding alarms for the month of March.
- Engine #901 Hearst Compartment was reconfigured. It will cost up to \$900. They are using the same company for this as they did for engine #905
- Reported 6-7 new members; there are 4 more coming in the next 2 months. The Chief requested new name plates that just say the firehouse name for the back of their gear so it doesn't look bare. Price per plate is about \$70. The chief is asking for 10 name plates. It was decided this will come out of the gear budget (account #6312)
- The chief asked if anyone looked into the Cranford Coop yet for the new chief vehicle. He is hoping this can be in place before either vehicle dies. He is hoping there will be a plan to present at next month's meeting. He wants to be proactive and not wait for a vehicle to fail.

Assistant Chief Report - reported by Kevin Umbach

- T4 Max camera (this is the older blue camera) the battery died. Price to get a new one purchased and shipped is \$123.65. This cost should come out of Equipment M&R.
- A new hose has to be purchased. The price for this is \$4,100.

- Tablet price went up since it was quoted last year. Cost is \$19.74 over budgeted amount. The price is \$79.98 monthly. This does not include brackets. This still needs to be researched.

Engineer's Report - reported by Ken Skalla (see attached and notes below)

- On March 27th the hoses were all tested. There were various fails. Those that failed are being repaired.
- It was decided to hold off on any repairs on the Crown Victoria.

Rumors – reported by Jack Kramer

- People have been spreading rumors about him (Jack Kramer) and his damaging a fire company vehicle. He doesn't appreciate what has been said and if anyone has any issues, to please come to him about it rather than behind his back.

Before Public portion was close the following purchases were voted on:

- Purchase of the Hearst Bracket for \$900.00
- Additional \$19.74 per tablet purchase

Commissioner Duffy made a motion to approve these purchases; Commissioner Miller seconded them. There were no oppositions. They were so moved.

Public Portion closed at 20:17.

TREASURY REPORT - reported by Commissioner Wood (see notes below and attached)

- Last year we were over paid. Included in the disbursements is a check to pay the township back.
- Bank of America is dropping the fire house account under the State of New Jersey Deposit Protection Act. A new bank has to be chosen by July 9th, 2015 when the current accounts will need to be closed. Commissioner Wood and Christine Gerbereux, bookkeeper, like TD Bank. Chris is going to look and see if they will take on their accounts. If not, they will have to go back to Provident. In total, 2 accounts have to be moved. There was a question raised about an escrow account at TD bank – do they have that option?

Beginning balance as of March 17, 2015 was \$469,992.66

After disbursements the ending balance is \$557,124.08

Please refer to the details in the attached document of all disbursements for the month.

Commissioner Duffy made a motion to accept the bills as read. Commissioner Miller seconded that motion. There were no oppositions. It was so moved.

OLD BUSINESS:

- The Fire Protection Agreement was signed by Commissioners Miller and Bowne. It was also signed by James Thigpen, Secretary and Michael Duffy, VP for the Brookview Volunteer Fire Company.
- The beneficiary forms have been updated. Companies changed which is why this happened.

PLEASE TAKE NOTICE that the Commissioners of Fire District No. 3 in the Township of East Brunswick, County of Middlesex (the "Fire District") intends to participate in the Houston-Galveston Area Council (HGAC) Cooperative Purchasing Program for the acquisition of a Firetruck. Information regarding the contract may be found at the administrative offices of the Board of Fire Commissioners, East Brunswick Fire District No. 3, Brookview Volunteer Fire Company Firehouse, 361 Dunhams Corner Road, East Brunswick, NJ during regular business hours as well as on the website of the Houston-Galveston Area Council: HGACBuy.org. The Fire District authorized membership in the HGAC Cooperative Purchasing Program in a resolution previously adopted by the Fire District. A contract was signed between the Fire District and HGAC shortly after such authorization for the contract period of Jan 1, 2015 through Dec 31, 2015. You had also asked about outdoor music on the property. The Township noise ordinance does not allow sound levels over 65dB between 7 a.m. – 10 p.m. and not over 50 dB between 10 p.m. to 7 a.m. Live bands may likely exceed these limits.

The dates we would need to have a tent for are April 17th, 24th, 25th and 26th.

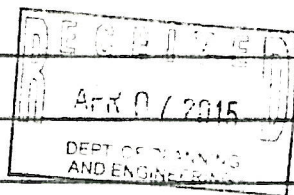

FIRE PROTECTION AGREEMENT

THIS AGREEMENT, made this 10 day of March 2015, between

THE BOARD OF COMISSIONERS OF FIRE DISTRICT NO. 3

IN THE Township of East Brunswick, County of Middlesex, and State of New Jersey, (hereinafter referred to as "Commissioners"); and

BROOKVIEW VOLUNTEER FIRE COMPANY

(Hereinafter referred to as "Fire Company")

WITNESSETH:

WHEREAS, N.J.S. 40a:14 70.1(B) authorizes the fire district of a municipality to contract with a volunteer fire company for the purpose of extinguishing fires, upon such terms and conditions as shall be deemed proper; and

WHEREAS, the commissioners of Fire District No. 3 in the Township of East Brunswick, County of Middlesex, have negotiated an agreement with the Fire Company within its jurisdiction upon terms that are fair and proper for the provision of fire protection services to the fire district;

NOW, THEREFORE, the Commissioners and Fire Company, in consideration of the payment to be made as herein described and the exchanges of mutual promises, represent and agree as follows:

- 1) Fire Company will extinguish fires within the fire district or in such other areas or territories as may be contracted for by commissioners or pursuant to mutual aid agreements. For purposes hereof, the term "extinguishing fires" shall be used in its broadest and most universal sense.
- 2) Nothing herein shall be construed to increase any liability on the part of Fire Company to the public for errors or omissions in the performance or nonperformance of its duties hereunder or pursuant to any other requirement.
- 3) The members of Fire Company, in performing fire duty, shall be deemed to be exercising a government function.
- 4) The members of Fire Company shall operate under the supervision and control of Commissioners, and Fire Company may not take any action which is contrary to law or to the by-laws or official actions of Commissioners.

- 5) Fire Company shall perform such other duties, directly or indirectly related to the extinguishment of fires, as may be directed from time to time by Commissioners.
- 6) In addition to the payment to be made as hereinafter provided by Commissioners to Fire Company pursuant hereto, Commissioners shall provide Workers Compensation Insurance coverage and also liability insurance protection for fireman while engaged in fire fighting duties, including their use of apparatus, vehicles, and equipment owned by Fire Company, public liability and property damage insurance for the fire houses or structures owned by Fire Company.
- 7) Commissioners shall reimburse volunteer firemen of Fire Company for any personal losses incurred while engaged in fire duty, subject to reasonable proof of the value of such losses.
- 8) Commissioners shall pay Fire Company the amount of **ONE HUNDRED AND NINTY THOUSAND SIX HUNDRED DOLLARS (\$190,600.00)** for the services herein provided, said annual consideration shall be made in installments pro-rated to the amount received by Commissioners from the Township as the fire district's share of tax revenue, **each installment to be made within thirty (30) days following receipt of said revenues by the fire district.**
- 9) The payment to be made hereunder is dependent upon Fire Company maintaining an adequate fire fighting corps and an available manpower response during all hours of the day.
- 10) Notwithstanding anything to the contrary herein contained, Commissioners will exercise jurisdiction over Fire Company in firematic matters only and will not interfere or seek to regulate the internal administration of Fire Company. The control of the Fire Chief at the fire scene, in accordance with law, shall remain exempt from the foregoing.
- 11) Commissioners shall provide life and health insurance for the members of Fire Company, but not in excess of any statutory limit, and any insurance, once in force, may not be terminated by Commissioners without furnishing thirty (30) days notice to Fire Company.
- 12) Fire Company will house any apparatus, vehicles or equipment furnished by Commissioners in a safe and secure manner, will observe any rules or regulations promulgated by Commissioners for the maintenance, storage and use of said apparatus, vehicles, and equipment, and shall utilize same only in accordance with procedures established by Commissioners and to effectuate the purpose of this agreement.
- 13) This contract is contingent upon adequate funding being provided in the annual budget and by appropriation of Commissioners.
- 14) At the expiration of this agreement, in the absence of a new or replacement agreement, the parties may continue this agreement upon the same terms and conditions for an additional period of ninety (90) days by letter authorization, without the need for a formal contract.
- 15) Fire Company may not hire or employ any person to perform any firematic function of Fire Company, but Commissioners may provide paid

- employees for use by Fire Company provided that the requirements of L. 1979, c.453, and subsequent amendments, if any, are observed.
- 16) Commissioners shall receive use of the office space presently provided for the Board of Fire Commissioners at Colonial Oaks Firehouse unless subsequently agreed otherwise by the parties.
- 17) The meeting room at the Colonial Oaks Firehouse shall be available for the use of the Board of Fire Commissioners for its regularly scheduled evening meetings on the 2nd Tuesday of each month, for the annual election meeting held on the 3rd Saturday in February, and for special meetings, from time to time, provided that such meetings do not conflict with other activities previously scheduled by Fire Company for said room.
- 18) All duties, obligations, and activities of the parties pursuant to this agreement shall be exercised reasonably and in good faith.
- 19) If any articles, sections, paragraph, sentence, or clause of this agreement is determined to be invalid, same shall be deemed severable, and the remainder of the agreement shall survive unless such invalidated language is material to the purpose and intentions of the parties.


