- Nothing to report this month

INSURANCE (reported by Commissioner Duffy)

- Received renewal for Workman's Comp insurance.
- All other NJM insurance has been taken care of. Commissioner Duffy spoke to the firehouse rep this morning regarding the insurance renewals. Christine Gerbereux reviewed the documentation from Tom and saw the first premium was due. A check was cut and included this evening to be paid.

COMMITTEES

Riva Avenue Project (reported by Commissioner Duffy)

- Things are moving along well. Next two weeks they will be closing things up. Everyone's been great doing what they have to do.
- At present Commissioners Bowne, Duffy and Miller receive Requests for Changes from Linda at Design Collaborative. These Commissioners received an email today from Linda regarding a few changes to the project. Tom will print out and review after today's Treasury report.
- (This was reported after the Treasury Report was read)
Commissioner Duffy printed out the Request for Change email from Linda today and went through it with the Commissioners. She was able to negotiate better pricing for a few changes that occurred this month. The list below reviews what the changes are about requesting approval from the Commissioners. Once approved Linda will submit the proper forms so these items can be paid for.
 - Pipe change (RFC29). Kane Eddie decided to use a heavier thicker pipe to be installed under the new driveway. This was done without notification to the board. They felt that they should not pay because they didn't go through the proper channels however they did it to benefit us. Original bill was over \$900.00, and Linda got it down to \$477.36.
 - Door lintel that had to be beefed up (RFC34) – original prices was \$918.00. Linda got it down to \$782.92.
 - Door 101 (RFC42) – this was not in the original contract – it had to be swapped out. \$840.89
 - Breezeway lintel and sheetrock stair enclosure (RFC44) - \$2,645.00 additional work. \$2,250.42 pending research on the drywall. Linda asked that it be approved this tonight, but it may come down more
 - Perforated pipe that got added to the storm sewer (RFC52) to connect all the front drains off the gutters. Cost is \$1,081.91.
 - Washroom lally column problem (RFC55). Price for this fix is at \$1,568.92. Originally this cost was \$3,000.00. Linda recommended that this be approved for either cost because they may through in a few things that Linda requested and if they do then the approval should be for \$3,000.00 – either way it is a win/win for the firehouse.

Commissioner Duffy made a motion after each Change Request from Linda to approve. Commissioner Wood seconded that motion after each Change Request. All were in favor and each were approved to be submitted.

There was a special meeting held for the electrician regarding the charge of \$18,000.00 for the new generator and all its components with set up. It was a huge benefit to the firehouse to get this all taken care of now because it brought a savings of over \$46K.

TREASURY REPORT (reported by Commissioner Wood)

Beginning balance in account as of 4/16/18 after a deposit of \$364.72 is \$1,498,996.46. After disbursements tonight, balance is \$1,317,095.21. The next Interlocal is due in July so it will be paid in June. It will be paid with next month's invoices.

- Received document from GovDeals.com showing we sold the Crown Vic on their website and details what the transaction was. We should receive a check from them by next month to finish out this sale.



NEW JERSEY STATE ASSOCIATION OF FIRE DISTRICTS
LEGISLATIVE REPORT

QUARTERLY MEETING
March 3, 2018

Presentation of Plaque to Assemblyman (now SENATOR) Troy Singleton: We had to reschedule this event. We are working on getting a date in March at his district office.

Meeting at Department of Community Affairs: I am in the process of scheduling a meeting with Rob Long, the new deputy commissioner of DCA to discuss the promulgation of rules to implement the new election date change law and to discuss other issues with the Division of Local Government Services, the Local Finance Board and the Division of Fire Safety.

Lame Duck Action

Amendments to State Construction Code

S3284, VanDrew/A96, Prieto - Implements recommendations set forth in reports from the Code Advisory Council and ad hoc committee formed by the Fire Safety Commission regarding fire safety in lightweight wood construction and the installation of NFPA 13 versus NFPA 13 R sprinklers. It also imposes limits on the height of the construction of buildings on top of structures such as parking garages.

S3293, VanDrew/A97, Prieto – Mandates that a “fire watch” be established during the construction of Residential R1 or R2 structures during times when active construction is not taking place.

Despite being a “legacy priority” of the former Speaker, these bills died in the lame duck.

FIRE SAFETY COMMISSION MEMBERSHIP

A5076, Wisniewski/S3458, Bucco – Increases membership of fire safety commission by four members who shall be “members of the public who are knowledgeable and experienced in matters related to fire safety.

Even though the bill passed both houses unanimously, Governor Christie gave it a pocket veto. It has been reintroduced in the new session. (see below).

FIRE SUPPRESSION SYSTEMS

A5074, Quijano/S3416, Greenstein – Directs Division of Fire Safety in DCA to survey fire suppression systems in public and nonpublic school buildings.

After passing both houses unanimously, Governor Christie did sign this into law on Jan 16, 2018, P.L. 2017, c. 318.

A4517, Wisniewski/ S3213, Stack – “New Townhouse Fire Safety Act” – Requires installation of fire suppression system in new townhomes.

Introduced on Jan 23 and referred to the Assembly Housing Committee.

DIED in the lame duck.

A2251, Wisniewski – Requires builders to provide information on fire suppression systems to new homebuyers.

DIED in the lame duck.

A3334, Wisniewski – Requires fire suppression systems in new single and two family homes.

Introduced on Feb 22 and referred to the Assembly Housing Committee.

DIED in the lame duck.

FIRE SPRINKLER TAX EXEMPTION

A4564, Quijano/S3022, Greenstein – Exempts from sales tax purchase of fire sprinkler systems in residential new construction.

DIED in the lame duck. Reintroduced in the new session (see below).

WATER COMPANY MANDATES

A4805, Mosquera – Prohibits water companies from assessing more than one charge per fire hydrant to fire departments, fire districts or volunteer fire companies for use of fire hydrants.

A4806, Mosquera – Requires water companies to provide representative of fire department, fire district or volunteer fire company access fire hydrants for water flow rate testing purposes.

DIED in the lame duck. Reintroduced in the new session (see below).

REGULATORY COMPLIANCE FOR POST-RETIREMENT VOLUNTEER FIRE FIGHTERS

A536, Schepisi/S2107, Sarlo - Provides PERS or PFRS member who continues to be volunteer fire fighter after retirement with employer from whom member retires has bona fide severance from employment for compliance with NJ Regulations and IRS Code.

Passed both houses unanimously in the lame duck but pocket vetoed by the Governor.

SPECIAL NEEDS REGISTRY

S2436, Bateman/A3784, Zwicker – Establishes a registry of persons with special needs for use during emergencies.

DIED in the lame duck.

The New Session

SHARED SERVICES

S1, Sweeney/A1839, Lampitt – Encourages sharing of services.

Both bills were introduced on Jan 9, 2018. S1 was heard and released by the Senate Budget and Appropriations Committee on Feb 9.

FIRE SAFETY COMMISSION MEMBERSHIP

A2987, Bucco/S1799, Bucco – Increases membership of fire safety commission by four members who shall be "members of the public who are knowledgeable and experienced in matters related to fire safety.

Both bills were introduced on Feb 8, 2018. A2987 was referred to Assembly Homeland Security and S1799 to Senate Community and Urban Affairs.

FIRE SUPPRESSION SYSTEMS/FIRE EXTINGUISHERS

A3111, Benson – Requires new single and two-family homes to be equipped with fire extinguishers.

Introduced on Feb 8, 2018 and referred to the Assembly Housing Committee.

FIRE SPRINKLER TAX EXEMPTION

A1752, Quijano – Exempts from sales tax purchase of fire sprinkler systems in residential new construction.

Introduced on Jan 9, 2018 and referred to the Assembly Housing Committee.

WATER COMPANY MANDATES

A429, Mosquera – Prohibits water companies from assessing more than one charge per fire hydrant to fire departments, fire districts or volunteer fire companies for use of fire hydrants.

A430, Mosquera – Requires water companies to provide representative of fire department, fire district or volunteer fire company access fire hydrants for water flow rate testing purposes.

Both bills were introduced on Jan 9, 2018 and referred to the Assembly State and Local Government Committee. I am in the process of scheduling a meeting with her to discuss expanding upon the above two bills to address the raising of water rates/cap issue.
