The 2023 proposed budget has increased by \$55,606 in comparison to the 2022 adopted budget. This is mainly due to having a proposed Capital Appropriations of \$75,000 where there was none in 2022. And there was slight decreases in Administration Expenses, Cost of Operations & Maintenance Expenses, and Interest Payments in the Debt Service.

3. Explain any variances over +/-10% for each line item. Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

- 1) Total Administration Costs: Net 16.0% decrease due to reduction in Election Expenses which were higher in 2022 due to Covid19 cost changes made for the elections.
- 2) Total Capital Appropriations: Net 100% increase due to having a proposed Reserve for Future Capital Outlays in 2023, and there being none in 2022.
- 3) Total Interest Payments on Debt: Net 15.4% decrease due to a reduction in the Interest due on current debt.

4. Complete a brief statement on the impact the proposed Annual Budget will have on the Amount to be Raised by Taxation, the use of the Restricted and Unrestricted Fund Balance(s) and how they are complying with the Property Tax Levy Cap.

If Unrestricted Fund Balance is reduced by more than 10%, explain the projected impact on the following year's budget.

There is an increase in the Amount to be Raised by Taxation in the proposed Budget of \$55,606 (5.9%). This is mainly due to the increase in the proposed Capital Appropriation of Reserve for Future Capital Outlays of \$75,000 (100%). There was a slight increase in the Utilization of Unreserved Funds of \$5,000 (5%) as compared to 2022. The effect on the tax rate is an increase of \$0.0205, from \$0.3787 to \$0.3992. There was no Utilization of Restricted Funds used in this Budget.

In the 2023 proposed Budget the Fire District increased the Capital Appropriations by including \$75,000 in Reserve for Future Capital Outlays. The proposed Debt Service had a slight decrease due to a reduction in the Interest to be paid on the Debt. As stated in the 2022 Budget the General Bond Obligation for approximately \$780,000, which was to be used to purchase a new Fire Apparatus, has yet to be issued. The Fire Apparatus purchase was held up due to Covid19 issues has been ordered and is now expected to be delivered in the late Spring of 2023, which has pushed back the issuance of the funds. The Bond Obligation will still be with the Township of East Brunswick, and the final numbers will be finalized once the Funds are issued. The Bond Obligation was approved by the Local Finance Board on 12/8/21.
